Delta Chapter Centennial Celebration

The Delta Chapter of Kappa Eta Kappa was founded on February 9th, 1924. The Delta Alumni Association, in coordination with Delta Chapter, are hosting a series of Centennial Celebration events. The chapter is hosting a KHK House Party on Friday, October 11th, starting at 7 pm (until late). This is your chance to relive your college years and socialize in the chapter house basement. The Delta Chapter is hosting an Open House on Saturday, October 12th, starting at 11:00 am. There will be snacks, brats, burgers, and beverages for lunch. This is an opportunity to see all of the chapter house improvements that have been made over the years, meet the current active members, and learn about some of the activities the chapter is engaged in. Everyone (all ages) is welcome to the open house.

Following the open house, a banquet dinner will be held at Union South, 5:00 - 9:00 pm. An RSVP is required to attend dinner, and RSVPs were due on September 26th. Delta Housing Corporation Update

The Delta Housing Corporation (DHC) collects rent from the chapter to cover annual house expenses (pest control, insurance, and property taxes) plus house maintenance and repair expenses. The DAA has a House Improvement Fund, which helps enable DHC to make capital or large maintenance improvements to the house. Your donations to the DAA House Improvement Fund help us continue our mission to provide affordable housing to members of KHK while improving the house through maintenance and large capital projects.

While our ongoing mission is to keep rent for members as low as possible, over the previous three years the DHC has implemented an increase in rent in order to keep up with increasing tax, insurance costs, and to keep funds available to support major house improvements. After many years of consistent rates, in FY 2022-23 the DHC increased monthly rent from \$2,600 to \$2,800 (7.7% increase). In FY 2023-24, monthly rent was increased to \$3,000 (7.1% increase), and this year (FY 2024-25) rent was increased by \$300/month to our new current rate of \$3,300 per month (10% increase). Ongoing financial analysis will be performed to ensure that revenue will to keep up with increasing costs.

The past five years have seen many major improvement projects at the Delta chapter house. From 2018 through 2020, every room in the chapter house was renovated, including painting, drywall repair, electrical upgrades (light fixtures and ceiling fans), rebuilding of closets and walls, and flooring (some rooms). This work was accomplished in part from a large donation from the estate of Steve Paugh, and through generous donations from our alumni members of DAA.

After room renovations, attention was shifted to common areas of the house. The summer of 2021, the front and rear porches of the chapter house were re-stained, and the back parking lot gravel was replaced, with volunteer alumni and active members contributing their time to accomplish these projects. In the summer of 2022, the hardwood floors in all of the common areas of the house were refinished by Sergenian's Floor Coverings. The next major project the DAA and DHC wish to tackle is an update to the kitchen space, including replacement of lower kitchen cabinets and countertops to match the newer upper cabinets, replacement of the kitchen floor, and updated LED lighting in the kitchen and other common areas. We are working to obtain quotes from local vendors to perform these services.

We depend on donations from alumni to help continue our mission to improve the chapter house. Last year we had approximately \$9,400 in donations from our alumni to the House Improvement Fund. We did not spend funds on a major project last year, and now have a balance of approximately \$19,500 to use for our next major project, which will be kitchen cabinets and floor. To maintain cash flow for DHC, a loan from the DAA to DHC was executed in July of 2021, for the sum of \$20,000 at 2% interest. The rent increase by DHC to the active chapter will help to replenish funds towards the eventual repayment of this loan balance.

The DHC maintains a list of major projects that may come up in the future including installation of a whole-house sprinkler system for fire suppression, with an estimated cost of around \$80,000; replacing all windows in the house, estimated at \$68,000 (depending on the quality of the windows) with the addition of permanently installed air conditioner units, estimated at an additional cost of \$20,000. Your donations to the House Improvement fund will help us perform this important work.

Chapter Update

New initiates were welcomed into the chapter in Spring of 2024, with a banquet held on April 28, 2024 at The Great Dane, Madison, WI. The chapter welcomed KJ Dhande (D1482), Raghav Jindal (D1483), Fin Kuhse (D1484), McKenzie Kujava (D1485), Hunter Lawry (D1486), Abhay Mettu (D1487), Lexi Pietenpol (D1488), Praneet Popuri (D1489), Ethan Race (D1490), and Matthew Ye (D1491) as new active members. We also bid farewell to our Spring 2024 departing seniors Abhimanyu Gupta (D1439), James Hunt (D1417), Nick Im (D1441), Jack Rollins (D1447), George Vajagich (D1457), and Imogen Youngs (D1481). The Chapter currently has 44 active members. The Chapter is currently involved in rush activities for the Fall semester pledge class. The current pledge trainer is Ryan Young (D1480) and the chapter president Karan Kapur (D1462).

Last semester, a new Delta Chapter Exceptional Member Award was introduced, to recognize active members of the chapter who have gone above and beyond their normal duties. Members were invited to apply for this award, including a written personal statement, and several criteria including attendance, planning special events, and academic excellence were considered. The Spring 2024 awardees were Nicole Kemnitz (D1469), Dev Mehrotra (D1425), and Jack Rollins (D1447). Awards were presented at the Spring banquet, including a certificate, \$150 cash award, and a gift from the chapter president.

The chapter participated in Engineering Expo 2024, and their project was titled "Learn 2 Code".

Each year, we ask Delta Alumni for donations to the active chapter, which are used to fund rush events and activities, as well as provide publicity materials. In 2023-24, alumni donated \$4,800 to the active chapter, and the DAA dispersed over \$3,200 in donations to cover chapter rush events and activities.

DAA Update

The DAA had our annual meeting at the Delta Chapter House on Sunday, September 15, 2024. In attendance were the DAA officers – President Jerry Peplinski (D916), Treasurer Samuel Hurley (D1238), and DAA Secretary Parker Jorenby (D1402). Delta alumni Jack Rollins (D1447), Michael Stemper (D833), and John Vaughan (D1143) were also in attendance, as well as Delta Chapter President Karan Kapur (D1462). Officer reports were given, the budget for the upcoming year was passed and goals were set for the next year. A copy of the fiscal year (FY) 2023-2024 financial summary is

included with this mailing. Our 2023-24 FY ran from July 6, 2023 to July 18, 2024. Election of officers was the final order of business. The new officers are listed on the page just before the financial report.
